#The number of shares in which ANZ had an interest in Golden West Resources Limited (GWR) arising in connection with the Opes Prime AMSLAs as recorded in yesterday's announcement was incorrect, and the correct figure has now been included in this schedule.

##The schedule attached to yesterday's announcement indicated that ANZ had an interest in 15.322% of the total issued voting shares of Royalco Resources Limited (RCO) arising in connection with the Opes Prime AMSLAs. The total number of issued voting shares used to calculate this figure was incorrect, and the correct percentage figure has now been included in this schedule.

The schedule attached to yesterday's announcement indicated that ANZ had an interest in excess of 5% of the total issued voting shares in Alchemy Resources Limited (ALY) arising in connection with the Opes Prime AMSLAs. ANZ's percentage interest with respect to this company was based on information regarding the total number of issued voting shares in the company which was inaccurate. Having regard to the current number of issued voting shares in that company, ANZ does not have an interest in that company in excess of 5% arising in connection with the Opes Prime AMSLAs and accordingly that company has been omitted from this schedule.

The schedule attached to yesterday's announcement identified ANZ as having an interest in excess of 5% of the total issued voting shares in each of Batavia Mining Limited (BTV), Citadel Resource Group Limited (CGGCA), Comtel Corporation Limited (CMO), Cardia Technologies Limited (CNN), Contact Uranium Limited (CTS) (formerly Contact Resources Limited), Destra

Corporation Limited (DES), Intermoco Limited (INT), Jumbuck Entertainment Limited (JMB), Mobi Limited (MBI), Mount Burgess Mining NL (MTB), Norwood Abbey Limited (NAL), Northern Energy Corporation Limited (NEC) and Tawana Resources NL (TAW) arising in connection with the Opes Prime AMSLAs. As a result of the settlement of sale transactions in respect of shares in those companies, ANZ no longer has an interest in the companies arising in connection with the Opes Prime AMSLAs in excess of 5%. Accordingly, those companies have been omitted from this schedule.
