COMPLETION OF TANDARRA HEADS OF AGREEMENT

Catalyst Metals Limited (**Catalyst** or the **Company**) (**ASX: CYL**) advises that all conditions precedent to the Heads of Agreement with Navarre Minerals Limited (**ASX: NML**) (**Navarre**) have been satisfied and completion has occurred. Under the Heads of Agreement, Catalyst has the right to earn a 51% equity interest in the Tandarra Gold Project located north of Bendigo in Victoria.

In accordance with the terms of the agreement, Catalyst has issued 250,000 ordinary fully paid shares to Navarre and made a cash payment to Navarre of \$50,000.

Please find attached an Appendix 3B in relation to the shares issued to Navarre.

As part of the same transaction, Catalyst has been assigned Navarre's rights and interests in the Sebastian and Raydarra Gold Projects located in North Bendigo in return for the grant of a 1% net smelter royalty on Catalyst's entitlement to proceeds from future production on those projects. Tenements comprising the Sebastian Project are currently subject to licence renewal applications and discussions have been held with the Victorian Department of State Development, Business and Innovations in relation to this.
