Four Eagles Gold Project Update

Catalyst Metals Limited (ASX: CYL) ("Catalyst" or the "Company") is pleased to announce that EL4525 has been renewed by the Victorian Department of Primary Industries for a further two years and therefore the Condition Precedent contained in the Heads of Agreement between Catalyst's wholly owned subsidiary Kite Gold Pty Ltd ("Kite Gold") and Providence Gold and Minerals Pty Ltd ("Providence Gold") has been satisfied.

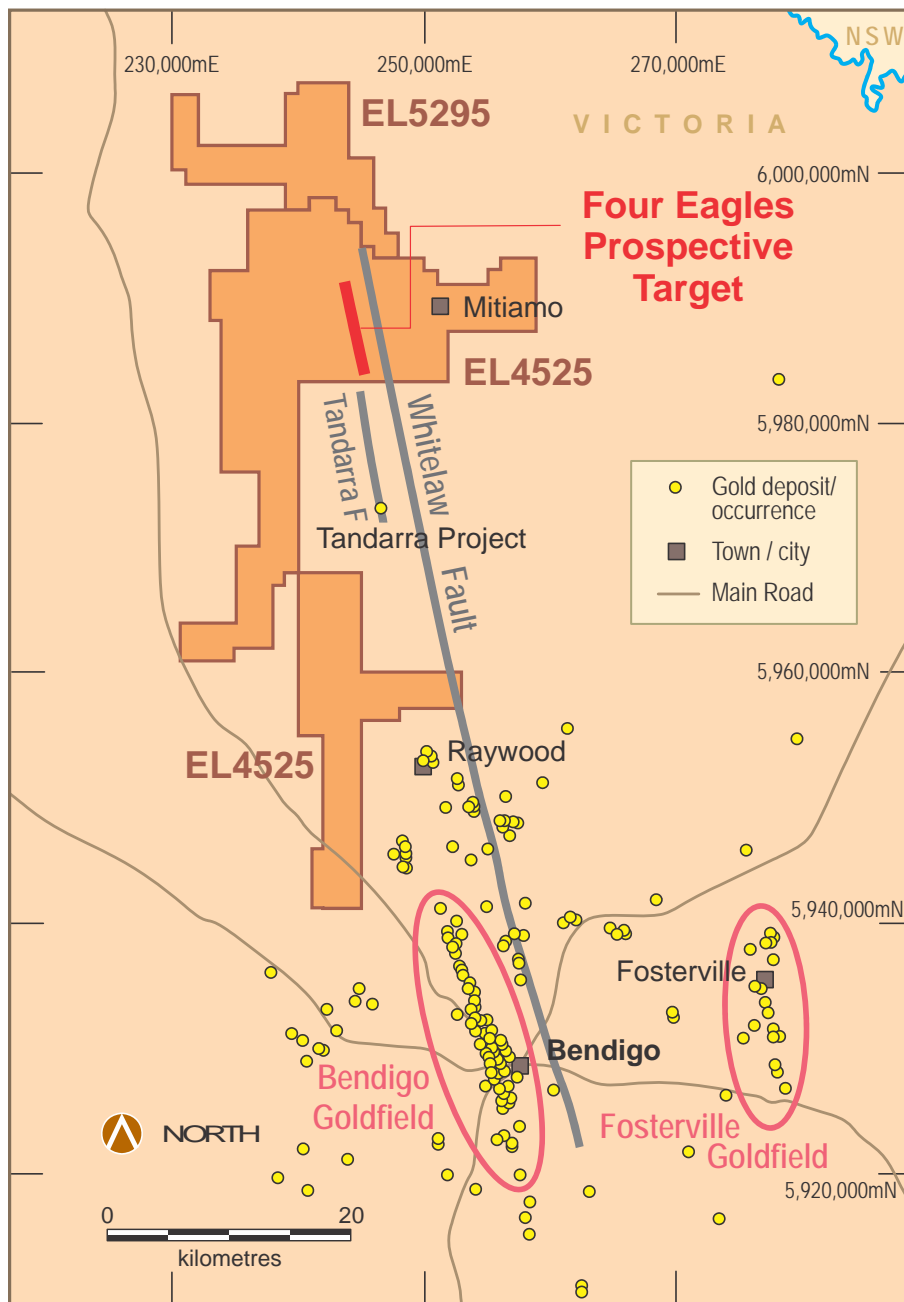


Figure 1: Four Eagles Project location

EL4525 and EL5295 ("the Tenements") constitute the Four Eagles Gold Project which is located generally along strike of the Bendigo Goldfield and west of the towns of Mitiamo and Raywood in central Victoria, extending from 20 to 70 kilometres north of Bendigo (Figure 1).

In accordance with the Heads of Agreement, Kite Gold has paid Providence Gold \$150,000 for the partial reimbursement of expenditure incurred on the Tenements and Catalyst has issued 750,000 ordinary fully paid shares to Providence Gold (refer attached Appendix 3B).

Kite Gold intends to start drilling in the first quarter of 2011 to test targets generated by previous drilling conducted by Providence Gold which included **6 metres @ 82g/t Au and 3 metres @ 9.7g/t Au**, 700 metres apart. The drilling programme will comprise approximately 60 air-core holes for 6,000 metres to further test the 25 kms of prospective strike length and 2 diamond holes for 700 metres to test the nature and setting of the high grade gold intersection.
